

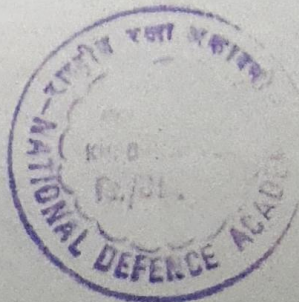


National Defence Academy, Khadakwasla, Pune - 411023 which is an icon Military Institution and a 'Centre of excellence' in Military Training, which was proven to be the Nursery of "Jointmanship" and the 'Cradle for leadership' for our Armed forces, through its Principal, Prof. OP Shukla (hereinafter referred to as "NDA", as Second part,

2. Whereas

- a. The NDA impart a structured pattern of training for three/four years comprising a wide variety of facets, which includes Outdoor, Military and Academic aspects in Jawaharlal Nehru University. On successful culmination of these three/four years of rigorous training, these cadets are awarded B.A. / B.Sc. / B.Sc. (Computer Science) and B.Tech degree from Jawaharlal Nehru University, New Delhi.
- b. At National Defence Academy, Pune as part of training both academic and military training complement each other for preparing the cadets to be the future leaders of the Indian Armed Forces. To this end, National Defence Academy has an undergraduate curriculum which enjoins the pursuits of cadet to be multi-dimensional to make him in turn a multi-faceted personality. To achieve this end, cadets need to strive hard for excellence, in all facets of training.
- c. The rigorous training of National Defence Academy at times, does take a toll on a few cadets, who are boarded out due to no apparent fault of the cadet. Hence, they require an admission in outside Colleges/Universities in their relevant subjects / streams to complete their study on migration basis.

- d. The National Defence Academy intends to sign a Memorandum of Understanding (MOU) with Guru Nanak Dev University in order to provide the much-needed rehabilitation to the boarded out cadets of National Defence Academy. It is proposed that migration admission be granted to them in Guru Nanak Dev University Amritsar Campus/ Regional Centres/Constituent Colleges so as to enable such cadets to complete Graduation degree course, after being boarded out of the National Defence Academy, Pune.

3. NOW THEREFORE, IN THE LIGHT OF THE ABOVE AND IN CONSIDERATION OF MUTUAL COVENANTS EXCHANGED HEREIN, THE PARTIES HEREBY AGREE AS FOLLOWS:


3.1. OBJECTIVE AND SCOPE OF THE AGREEMENT

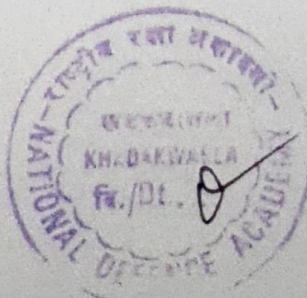
3.1.1 The objective of this Agreement is order to provide the much needed migration to the boarded out cadets of NDA in the Joint Services Academy of the Indian Armed Forces, for continuation of their studies at the Guru Nanak Dev University.


3.1.2 The roles and responsibilities of both the Parties and terms and conditions with respect to the above objective are specified hereunder.

3.2. TERMS OF MIGRATION

- a. The admission to cadets of National Defence Academy boarded out the students at Guru Nanak Dev University shall be done on migration basis on the recommendation of the National Defence Academy.
- b. The boarded out cadets of NDA will be allowed to migrate to Guru Nanak Dev University subject to satisfying the rules and regulations of the Guru Nanak Dev University as regards to maximum number of backlogs. Minimum grade point , marks in the courses completed etc.
- c. The boarded out cadets/ students are required to have obtained the minimum percentage of marks/ grade point in the qualifying examination i.e. 10+2 or equivalent as the Guru Nanak Dev University rules.
- d. The boarded out cadets / students shall be offered admission at Guru Nanak Dev University into programmes that are most appropriate for their background subject to availability of seats in those programmes.
- e. The boarded out cadets/ students may have to take additional courses of the previous semesters to satisfy the programme requirement of the Guru Nanak Dev University.

- f. The boarded out students shall pay the migration fees and the University fees as per the rules of the Guru Nanak Dev University
- g. The migrated students shall follow the rules and regulations of the Guru Nanak Dev University.
- h. The JNU which is the degree awarding institution for the NDA programmes will provide the migration certificate for the student migrating to Guru Nanak Dev University NDA shall facilitate the same.
- i. A character certificate for the student migrating shall be provided by NDA.

4. ROLES AND RESPONSIBILITIES

4.1 ROLE OF NATIONAL DEFENCE ACADEMY


- a. Recommending specific students for the Migration
- b. Facilitating the issuance of migration certificate from Jawaharlal Nehru University, New Delhi
- c. Providing character certificates to the migrating students
- d. Providing the details of the schemes of the programmes at NDA with the course details and syllabus from time to time
- e. Providing the marks sheets of the students migrating and mapping between grades and marks

4.2 ROLE OF GURU NANAK DEV UNIVERSITY


- a. Verification of the certificates of the students
- b. Assessment of the student suitability for migration in terms of programme, backlogs, grade points/ marks
- c. Assessment of the additional courses to be done by the student as per the requirement of the Guru Nanak Dev University.
- d. Admit the student on migration at Guru Nanak Dev University, if eligible for the B.A. B.Sc. (H), B.Sc.(Computer Science), B.Tech. as per Annexure A of this MOU.
- e. Inform NDA regarding the admitted students at Guru Nanak Dev University on migration

5. TERMINATION: -

- 5.1 This MOU can be terminated by either of the parties on three months' notice-from either side for the violation of any of the terms and conditions of this MOU.
- 5.2 However, if the MOU is terminated for whatsoever reason, the responsibility of each Party

shall continue to exist till the completion of the **Degree Programme** in different disciplines to which the students have been admitted before the date of servicing the notice of termination subject to the satisfaction of the University.

5.3 The University will make arrangement for completion of the course of the admitted students.

6. NOTICES:

6.1 Any notice or other information required by this Agreement to be given by a Party to the other Party may be given by hand or sent by speed/ registered post to the notified address.

6.2 Any notice or other information sent by email /facsimile transmission or comparable means of communication shall be deemed to have been duly given on the next day after transmission provided a confirmation of such notice is sent by post as mentioned hereinabove.

7. INDEMNIFICATION:


Both the parties shall indemnify and keep the other party indemnified and harmless against any and all claims, actions, proceedings by third party (including all costs, expenses, damages/losses) arising out of or in connection with this MOU due to breach of any provisions of this agreement by such party or as a result of any act of negligence/omission or commission on part of such party and/or its employees, agents etc.

8. MISCELLANEOUS:



8.2 This Agreement and any Annexure/s hereunder may be executed in two or more copies and each of which will be deemed an original for purposes of this Agreement.

8.3 In the event any change in any law, or the passage of any law, rule or regulation affects, or in either Party's reasonable determination, may affect, either Party's performance or obligations under this Agreement, the Parties shall work together in good faith to amend this Agreement so as to minimize or eliminate, the impact of such Changes in Law on a

Party's performance or obligations under this Agreement.


9. CONFIDENTIALITY

Each party (the "Receiving Party") undertakes to keep and maintain any and all information received under this Agreement from the other party (the "Disclosing Party") in the strictest confidence ("Confidential Information") and not to disclose (directly or indirectly) such information to any third party (except to its personnel and to the extent such disclosure is necessary in the course of performance of services under this Agreement) or make copies of any confidential information without the prior written consent of the Disclosing Party. The Receiving Party shall use the Confidential Information solely for the purpose of implementing the transaction contemplated herein and not for any other purpose. All such information shall remain the sole and exclusive property of the Receiving Party and upon termination or expiry of this Agreement; the **Receiving Party** shall return or destroy such information to the reasonable satisfaction of the **Disclosing Party**.

10. The agreement shall be valid for 3 academic years, ^{2021-22, 2022-23} ~~2023-24~~ from the date of signing the MOU which is extendable on mutual agreement.






